District Highlights:

Mr. K. Hacke, Superintendent, updated the board on several items.

- 1) The track/football renovation is going great. The sod has been laid and is looking good overall. The asphalt has been put down on the track but the overlay and striping are tentatively scheduled for the week of July 29th. The storage shed is being finished up. The south section of the middle school roof is complete and the intent is to be done with the north section by the end of July.
- 2) Transportation Report: The district's average age of buses is a 2012, average mileage is 94,937, and the districts miles traveled per year averages 263,114. The district used 1850 gallons of gas and 32,073 gallons of diesel fuel for the 2018-2019 school year.
- 3) Communication Report: Mr. Hacke complimented the district on the many forms of communication that is used within the district such as parent clubs, family activities/parent involvement, partnerships, committees, student recognition, communication, organizations, and community groups. He also discussed a new form of communication that may be implemented in the form of home visits.
